  - A. General Notes Clarification: Interior painting includes every room in the existing building (walls, door frames & H.M. window frames) not just rooms with room numbers and finish numbers. Finish numbers in existing rooms are to identify work other than painting.
3. Sheet A2.11:
  - A. Finish Schedule Clarification: Finishes F-5 through F-8 identify work, in addition to painting, in the existing building. The term "Existing Concrete Block-Painted" means "this is a room, in the existing building, where you are to paint the concrete block."
