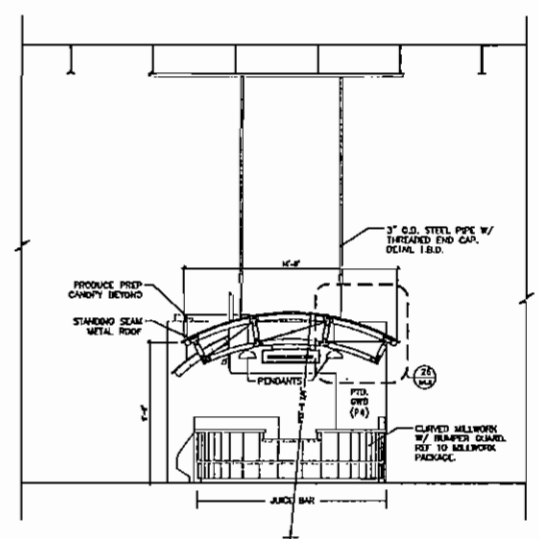
40 ELEVATION-EXIT/ CUSTOMER SERVICE

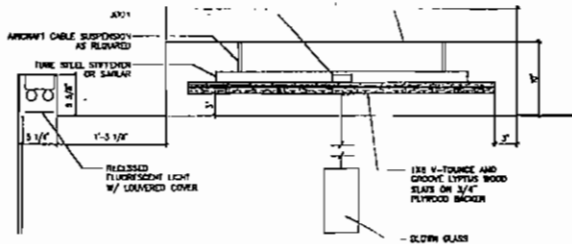
40 OUTDOOR FABRIC CANOPY-PLAN

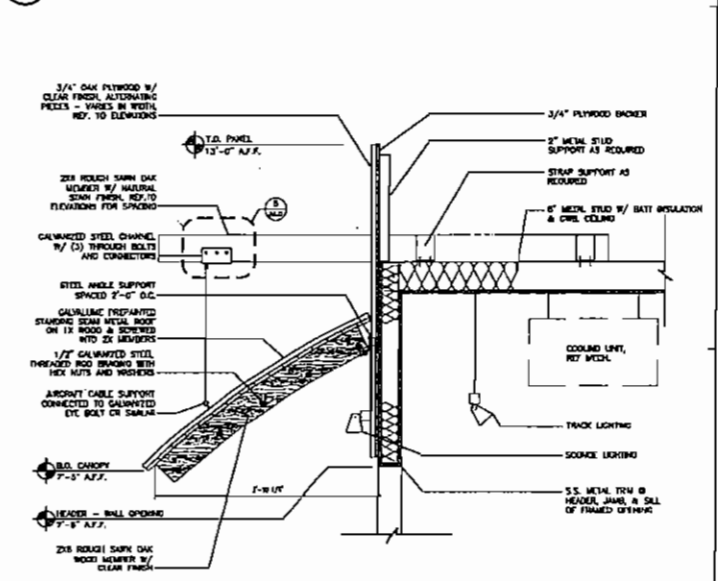


7 DETAIL-BOOTH CANOPY

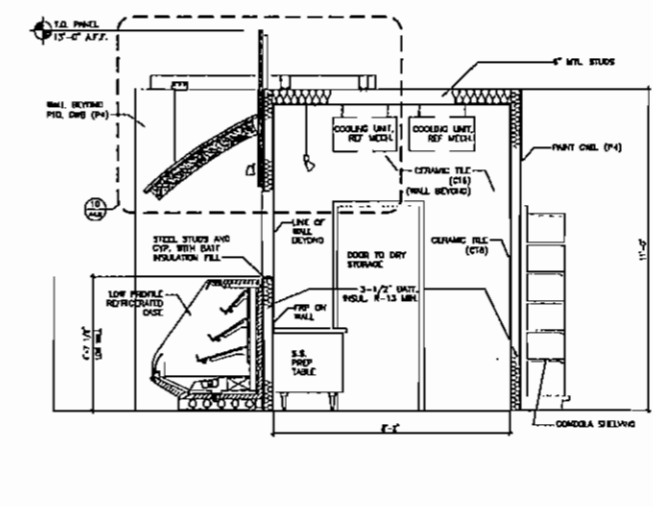


1 DETAIL-BOOTH CANOPY

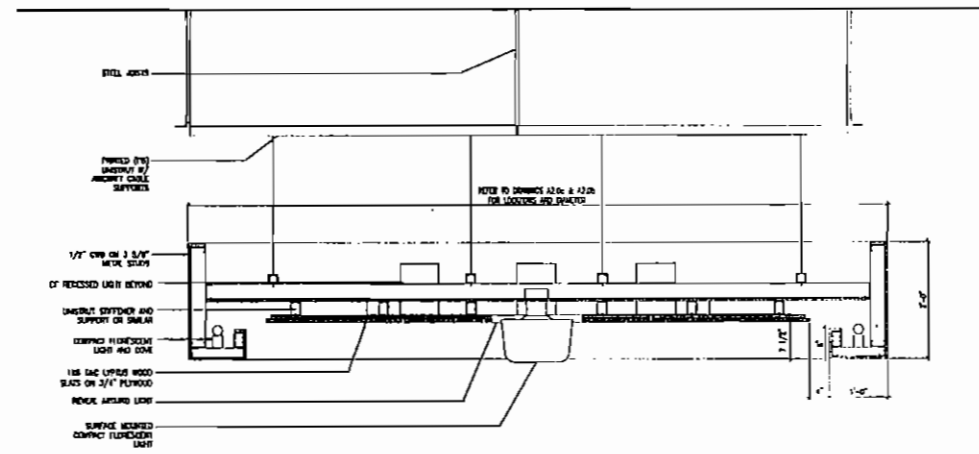


40 TILE PATTERN-FLORAL AREA
